

MEMORANDUM OF UNDERSTANDING BETWEEN
THE ORGANIZATION OF ISLAMIC COOPERATION [OIC]
AND
Peace Action Society Organization for Somalia (PASOS)

Memorandum of Understanding (hereinafter referred to as the "Memorandum") made between the Organization of Islamic Cooperation (hereinafter referred to as "OIC") and Peace Action Society Organization for Somalia (PASOS) (referred to as "the Organization").

Whereas OIC wishes to provide dates, tents and blankets to the Organization in the context of emergency response to the IDPs in Mogadishu of Somalia and on the terms and conditions hereinafter set forth, and Whereas the Organization is ready and willing to accept such emergency food and Shelter and distribute it as per the timeframe and format agreed under the Memorandum.

Now, therefore, the parties hereto agree as follows:

1. Responsibilities of the Organization

- 1.1. The Organization recognizes that it is responsible for undertaking food distribution and building of the shelter/activities including acquisition of the date and shelter from the OIC warehouse, transportation, loading, offloading, security, shelter building and distribution costs of the dates and shelter to the targeted beneficiaries.
- 1.2. The Organization has to acquire 37,940 Kg of dates, 96 of tents and 186 of blankets from the OIC warehouse by Tuesday, 30th December 2011.
- 1.3. The Organization shall either use the dates and shelter as part of the food package for the returnees or distribute it to the IDPs inside or outside Mogadishu.

2. Responsibility of OIC

- 2.1. OIC agrees to provide a total amount of \$ 7020 of 37,940 Kg of dates, 96 of tents and 186 of blankets to the Organization by Tuesday, 30th December 2011.
- 2.2. OIC agrees to provide the payment of transportation, loading, offloading, security, shelter building and distribution costs of the dates and shelter to the targeted beneficiaries as specified in the Article IV below.
- 2.3. OIC recognizes that it has overall responsibility for monitoring the distribution activities.

3. Duration

- 3.1. This Memorandum will come into effect on 30th December 2011 and end on 07th January 2012.

4. Payments

- 4.1. OIC shall provide payments to the Organization in the amount of \$7020 for the cost of transportation, loading, offloading, security, shelter building and distribution costs of the dates and shelter from the OIC warehouse to the targeted beneficiaries, and the payment shall be made after the completion of the activity.
- 4.2. The payment shall be in US dollar currency, and the money shall be transferred to the Organization after the completion report and other support documents on the expenditure of the money are submitted.

5. General Provision

- 5.1. This Memorandum shall form the entire any other negotiations, commitments or communications, whether oral or in writing, pertaining to the subject of this Memorandum.
- 5.2. The Organization shall carry out all the activities under this Memorandum with due diligence and efficiency. If at any time OIC is not satisfied with the quality of work or the progress being made, OIC may, in its discretion

withhold the payment, declare this Memorandum terminated by writing notice to the Organization and seek any other applicable remedy as may be necessary.

5.3. OIC undertakes no responsibilities in respect of life, health, accident travel or any other insurance coverage for any person, which may be necessary or desirable for the purpose of this Memorandum. Such responsibilities shall be borne by the Organization.

5.4. No modification of or changes in this Memorandum, waiver of any of its provisions or additional contractual provisions shall be valid or enforceable unless previously approved in writing by the parties in this Memorandum or their duly authorized representatives in the form of an amendment in this Memorandum duly signed by the parties hereto.

IN WITNESS WHEREOF the undersigned duly appointed representatives of OIC and the Organization, respectively, have on behalf of OIC and the Organization signed the present Memorandum of Understanding on the dates indicated below their respective signatories.
